

## Age Policy

You must be 18+ to pay for fursuit commissions. I will make suits for minors that are 13+, but a parent or guardian must be involved for payment and legal reasons. I do not make fursuits for children under 13, and I will not make bodysuits for minors for sizing reasons.

## Quotes

When commission spots are opened, you may contact me for a potential project. Please provide a digital reference sheet with all markings clearly shown, and with important details such as pawpads and mouth colors. All features you want on your fursuit should be shown in the reference. If you do not have concept art of your character, I can draw a reference sheet for a fee. You may also request an “artistic liberty” project, in which case, please provide a species, colors, themes, and details you want for your project.

## What I will and won't make

I will

- Make a large variety of species
- make uncommon real life species, such as insects, reptiles, birds
- make custom sculpted skull creatures
- make original species (open species and species you have made yourself)
- make suits that fit glasses. As I model all my headbases myself, this is an addition that can easily be made

I will not:

- make suits for morally repugnant people. If you have seriously harmed people or animals I have the right to not do business with you.
- Accept images made by generative AI as reference.
- make copyrighted characters that you do not own. Original characters from copyrighted IPs are alright, but they must be unique characters and not copies of existing ones.
- make suits of closed species that can be bought, species that are closed because you want them to be private to yourself and friends are fine
- make explicit body parts.

## Payment

When a commission is accepted, a down payment equivalent to the price of materials is required before starting work. The rest of the amount is either required to be paid off before work is started, or a payment plan is arranged to pay the full sum. Specific details about your payment situation will be attached to an addendum specific to your project.

I mainly use PayPal Goods and Services as a payment method. It is available internationally, and provides protection for both buyers and sellers. Alternatively, Etsy may be used, however

due to fees this will cost more. If for some reason you need to use a different form of payment, contact me and we can work something out.

## Work speed

I am a college student in a major that requires a lot of time. Fursuit work is done whenever my schedule allows. This means I may complete a ton of work during some free days I have, I may work a bit every day when I have a normal course load, or I may not work at all for a while when I need to focus on school. I schedule my commissions so I have the hours needed to complete projects within a deadline, but I cannot guarantee steady progress week by week that other makers may give.

I send out progress updates and wip pictures every time I work on your suit. I only work on 1 or 2 projects at a time. My absolute longest turnaround times (from when the project was first started) are 6 months for heads, partials, and bodysuits, and 2 months for fursuit parts. I try to make heads, partials and bodysuits in 3 months, and parts in 1 month, but this is not a guarantee. Wait times are counted from when a commission is started, and are longer if you are scheduled for a slot that is started in the future.

If you want a suit by a certain event or convention, let me know. I will deliver suits to events we both are going to. There is no additional fee, but I do not do deadlines that are sooner than 3 months from the start date, and I reserve the right to refuse a deadline.

## Communication Requirements

I send out updates and progress pictures every time I work on your project. Feedback is an important part of my work process. While the suit is being worked on, I ask that you be able to be contacted through a messaging service that allows for photos to be sent, as well as being able to respond to questions and input within 2~3 days. If you are going to be away from the internet for an extended period of time, please tell me so I can work around it.

## Revisions

Changes to the suits designs may be made during construction. Changes that don't require new materials (such as markings with existing colors, shapes of parts while they are being made) will require a small fee for labor. Any extensive changes will require fees for labor and materials, and if the changes are drastic I reserve the right to not make them.

## Measurements

It is your responsibility to give me accurate measurements when asked. Fullsuits and bodysuit commissions require a duct tape dummy to be sent to me. Please make your duct tape dummies according to the instructions I will provide you, I won't be held responsible for poor fit due to incorrectly made DTDs.

## Social Media Policy

I post WIP pictures of all the suits I make to my social media accounts. By commissioning me you agree to let me use pictures of your commission (both finished and unfinished) for self promotion.

If you wish for your commission to be kept a secret (either for a surprise reveal or to be anonymous), please let me know. I won't make entirely secret projects but I will keep you anonymous or delay posts if you request.

I like to tag my commissioners in their projects I post on social media. If you want to be tagged, let me know your usernames (preferably TikTok, Instagram, Bluesky, or a personal website).

## Refunds

Before work is started, the client may request a refund. This will cancel the commission and the commissioner will receive their money back, minus the down payment used to buy materials.

After work is started, usually there are no refunds. There are 2 exemptions: I (the maker) may cancel the commission, give you a full refund (including down payment), and keep any work created. This is only for extreme situations such as serious illness or moral reasons. If the commissioner has an emergency in their own life and requests a refund, I may (at my discretion) use this clause to give them a full refund. Additionally, if I exceed the maximum turnaround time (as outlined in Work Speed and Communication Requirements), you may request a full refund minus the deposit, and I will give you a refund as well as any completed work on the suit.

If payment is delayed, the project will not be sent out or worked on until you have paid, and if there is a significant delay and I have made many attempts to contact you and you don't respond, I reserve the right to cancel your commission and sell any work that is done.

## Shipping

Shipping is not included in the original price. An estimate will be given upfront, but this may change depending on shipping prices. All packages are shipped tracked and insured, if shipping internationally customs forms will be filled out and you may have to pay additional import taxes.

## Privacy

If you commission me, your private info such as your address and name will not be stored or sold to 3rd parties in any way. Your info will only be used to complete and ship your fursuit.

## Warranty and Care

All fursuit heads come with a 6 month warranty, covering repairs for any construction errors. The client pays for shipping to and from the maker, the maker pays for all materials.

All suits must be taken care of properly for the warranty to apply. This means washing, cleaning, and brushing the suit after use. In addition, suits must be clean when sent in for repairs. Any unclean suits void the warranty and will not be repaired.

Any modifications made by a third party or yourself must be pre approved, else the warranty is void.
